

1. The intending supplier should be registered Firms with GST registration.
2. The rate quoted shall be deemed to be valid till 31st March, 2019 for supply of these items as and when need arises.
3. The rate to be quoted should be for **one unit of each item**, and legibly written and should be comparable to GeM rates. The rates quoted should be inclusive of the GST which should be clearly noted separately (i.e rate **Rs.10000/- + GST- Rs.1800/- = Rate + GST = Rs.11,800/-**)
4. Each Tenderer should submit attested copies of up to date GST clearance certificates and experience certificate etc.
5. Each bidder shall make available one sample for display and functional assessment by an internal committee at Guwahati as per the requirements of tender committee to judge the suitability of the furniture items as per the technical specifications within 5 (five) days of submitting this bid. Those items that are found functionally satisfactory in technical assessment will thereafter be assessed on the financial bid. The lowest bidder among the selected bidders in each category of furniture shall be asked to supply at the least rate quoted for that category of furniture.
6. No delivery charges will be paid to the firms by the undersigned for delivery of the articles in the office.
7. The undersigned is not bound to accept the lowest rate and reserves the right to reject any or all the quotation rates without assigning any reason thereof.
8. The undersigned reserve the right to cancel the NIT, reject any or all the Tenders received at this end without sighting any reason thereof.
9. The sample shall be inspected by the technical committee for functional use and compliance to technical specification.
10. The purchaser reserves the right to increase or decrease the no. of articles under each category of furniture by 25%.
11. The items supplied should be of standard manufactures compliant with ISO:9000 series certification.
12. The make and model of each item should be clearly indicated along with the specification of the product matching with the specification as laid down.


